## **Statement of Hazardous Nature**

## **Section 4 - First Aid Measures**

#### **General Information:**

# **Section 6 - Accidental Release Measures**

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective chemically resistant clothing including eye/face protection, gauntlets and self contained breathing apparatus. Suitable materials for protective clothing include no specific manufacturer recommendations. Use impermeable gloves with care.
